I wanted to provide some info on the new FCC fees for new Amateur Radio licenses and vanity call applications. Amateur Radio has enjoyed a no-fee situation for quite a while even though the FCC has had the authority to impose fees for amateur licenses for some time. Effective 4/19/2022 applicants for new amateur radio licenses and applicants for a new vanity call sign will be charged a \$35 fee by the FCC. This is in addition to the \$15 test fee charged in ARRL VE test sessions.

Notice this is for NEW license applications only. Applications to upgrade the license or renew the license will not have a fee. This is good news.

So how this will work is: if unlicensed John Doe comes to one of our ARRL test sessions (or an ARRL session anywhere) to take the technician exam they will pay the \$15 test fee to take the exam. When they pass the exam, the ARRL will send that application to the FCC and the FCC will then email the new license applicant a link where they can go on the web and pay the \$35 fee. The \$35 fee will NOT be collected by the VE team at the test session. Also, if John Doe passes the technician and takes the general class and passes that as well, that is ONE application to the FCC and he will owe just \$35. Then when John Doe comes to another test session in the future and passes the Extra class exam, he will of course pay the \$15 test fee at the session but the FCC will not charge a fee to upgrade his current license.

I hope that helps. I know that additional fees and costs are a bummer, but \$35 is a small price to pay to get a license and enter the greatest hobby in the world!!!

Hamtoberfest is coming!! October 15 2022 is the date for the TARS Hamtoberfest hamfest. Plan to come out and have a good time, and also plan to help plan and execute this event. It takes some work, and the more folks who take a role, the less work for everyone involved. We need you. Watch out for how YOU can be involved. And spread the word on radio nets, email, etc.

The club is also taking donations of equipment, parts, pieces, etc that we can sell at our flea market table at the Hamtoberfest. If you have some stuff to clean out and need it out of the way we can come pick it up and help you out. It's a big help for the club as well. ## My Father, TARS First President By Bruce Hatfield, W9GFS

My father, Philip Hatfield, W9GFS, was one of the founders and the first president of TARS. He was an obsessive ham yet he was



a great father and never neglected my sister or I. But we sure did get caught up in all things ham. Although I never got a license until I was 67 years old, I feel as though I have been a ham all of my life. You can see that from the picture of me posed in my father's ham shack in 1954 when I was 2 years old. Every summer



I went to the local Hamfest with my dad. We dressed in identical shirts that my mother had stenciled W9GFS on. Yes, she had her role to play in his love of all things amateur radio. Saturdays we visited Wesco Radio or Castrups to buy new parts for the latest piece of ham equipment he was building, because of course it was all home built. This was because my father was an electronics engineer at the General Electric receiving tube plant located in Owensboro Kentucky. Funny fact, my sister was an adult before she knew that ham radios could be purchased commercially. Further funny fact, in high school when my friends drove over to see me for the first time, as part of the directions on how to find me I told them to look for the house with 4 towers in the yard.



I was never able to master the code and I never was able to get the license in his lifetime. But I was still so much a part of ham radio, from helping erect towers, to fishing feed lines down conduits, to moving his giant amplifier cabinet, I was an indispensable assistant around the ham shack. I even got to be quite handy with a soldering iron by the time I was in the fourth grade. My first summer job was unsoldering and sorting resistors and capacitors from junked radios for pennies per component. Not quite the same as a paper route!



CW, DX, RTTY were my fathers modes. There was no digital in his lifetime. When you become W9GFS in 1929 there aren't as many opportunities. He only did voice rarely and that was generally in the car. You have heard the expression, "as big as a bread box." Well, his tube powered car ham gear was literally that big and attached to the steel dashboards of the two cars we owned in that day. Parking in garages was impossible in most cases unless there was clearance for the antennas on the cars. That often meant the great on street parking search when we were in a big city. Final funny fact, my father had a ham radio on a timer that would come on in the late afternoon in a place that my mother could hear it. He would call CQ from the road on his way home

from work in Owensboro at several towns along the way. My mother was assured that he was safely on his way in inclement weather. As an added bonus she knew when to have dinner on the table.

He never quit being a ham. When he died in 1987 there was an unfinished project on his workbench in the basement of his house. As far as I know the parts and homemade boards are still on that bench.

## One Man's Opinion

#### Reprint from November 2016, In memory of Bill Hilyerd K4LRX (SK)

As most of you know I am an avid Dxer, love chasing the rare ones, or adding more band countries to my DX challenge award. So, why do I prefer to dx on the ham bands instead of local rag chews?

Well, I suppose it all started back in my Novice days of 1956-1957, back then I had a very meager station a transmitter with 30 watts of input power. If you figured 80% efficiency of a class C amplifier at that point in time you had about 24 watts output. Couple that with the high SWR my end fed Zepp had, of course you could make it work with the antenna tuner and I did. However, my actual power output had to be somewhere around 10 watts maximum, but this did not cause me to quit trying for those distant contacts.

I soon learned about the eighty-meter Novice Band, it was 3.700 to 3.750KHZ and it was full of signals during the evening hours. I observed that the closer states produced strong signals, while those further away were weaker in comparison. It was that time I wanted to see how far my signal could go, I often waited till someone ended a contact and copied the call letters of both stations. If one station indicated he was in a call district where I needed states, I used the tail ending call. This worked often, during the evening the zero district would start to come in very well, we gained a few new states. Sometimes I would hear the first, second, third district and would rack up new ones.

I started to read ham radio magazines about dx stations and my thoughts were if they can do it, so can I. So, in 1958 I began a wonderful journey in ham radio, I became a DXer and have not looked back.

To me, there is nothing more thrilling then to hear a rare dx station pull my call out of the pile up, it was a thrill back then and it is still that today. When I give some thought about it, my voice, or my CW has been heard around the world. Just to give an example my latest DX was Central Kiribati, we worked this one on 40 SSB, 15 CW and 20 CW. There has not been much activity on this island nation for many years.

What pride I had in my operation when I worked them all a few years ago while working an expedition to South Georgia Island.

You see some countries you may have never heard of, much less know anything about the culture. Ham Radio has increased my knowledge of the world, you can mention a country and I can usually tell you where it is, or something about it.

Shortly after I worked the last one on the DXCC list another entity was added since it met the requirements and that was North Korea. However, little to no activity has ever surfaced from this country and doubtful it ever will.

But hope springs eternal, I rarely work any one stateside on HF, only band I do is six meters when it is open, we still have hopes of gaining our 50th state and that is Hawaii, it seems no one operates six in the Aloha State. Maybe one day, but we have been stuck at 49 for several years.

To me there is nothing more rewarding then to hear my call letters pulled out of a big pile up by a rare DX station. I suppose one has to as they say have this in your blood, however I just enjoy doing it and have no plans to quit chasing DX. I have plenty of stories to share, I have fond memories of several contacts with Europe while operating Mobile. There was a park in my home town of Louisville that had a lookout, by driving up to the top of the hill you were about 1500 feet above the city. The contacts just kept coming, lots of fun that day.

I recall working Japan on 75 meters and also stations in New Zealand and Australia in the early hours of a winter morning. Nothing like it, I found working gray line propagation on this band to be fascinating.

Memories of working the very last entity on the DXCC list, making the final contact for five band DXCC, plus gaining the last few countries for honor roll status. Yes, all good DX memories, they just keep coming!

In order to make memories, you have to be on the air, own a radio, use it. Otherwise, you have nothing to show for your efforts in working for a ham ticket.

Would I trade my memories of being a DXer to someone else who is not? No, I would not change a thing, for those of you that are impressed with numbers you can check me out on QRZ.com. Look at the log book entries and the number, no there are no stateside contacts in the mix, just dx. No, would not change a thing.

And that my friends is "One Man's Opinion" Bill, K4LRX

## New FCC Application Fee Will Not Apply To Amateur Radio License Upgrades

The Federal Communications Commission (FCC) staff has clarified in response to an ARRL request that the new \$35 application fee will not apply to most license modifications, including those to upgrade an Amateur Radio Licensee's operator class and changes to club station trustees. The FCC staff explained that the new fees will apply only to applications for a new license, renewal, rule waiver, or a new vanity call sign. As previously announced, the new fees take effect on April 19, 2022.

"We are pleased that the FCC will not charge licensees the FCC application fee for license upgrade applications," said ARRL Volunteer Examiner Coordinator (VEC) Manager Maria Somma, AB1FM. "While applicants for a new license will need to pay the \$35 FCC application fee, there will be no FCC charge for future upgrades and administrative updates such as a change of mailing or email address. Most current licensees therefore will not be charged the new FCC application fee until they renew their license or apply for a new vanity call sign."

ARRL previously reported that the new \$35 application fee for Amateur Radio licenses will become effective on April 19, 2022. Further information and instructions about the FCC Application Fee are available from the ARRL VEC.

## A New World Distance Record at 134 GHz

On March 2, 2022, Michael Kuhne, DB6NT, and his son Matthias, DK5NJ, established a new world distance record at 134 GHz by making contact using CW over 157 kilometers (98 miles) between the summits of two mountains in Germany.

The portable microwave stations were located on Schneekopf mountain in the Thuringian Forest and atop Fichtelberg mountain near Oberwiesenthal. Check out the <u>video</u> of the record-breaking contact.






## WSPR Beacon on the Air from Antarctica

AMSAT Argentina has assembled and delivered a permanent WSPR (Weak-Signal Propagation Reporter) beacon system to the



Argentine research station at Esperanza Base on the Antarctic

Peninsula. Using the call sign LU1ZV, the 200 mW beacon is presently active on 40, 20, 15, and 10 meters at 7.0386, 14.0956, 21.0946,

and 28.1246 MHz, respectively, and reception has been reported by stations throughout the world.

The LU1ZV WSPR beacon is on the air from Esperanza Base, a permanent Antarctic research station.

WSPR is a digital communications protocol designed for reception at very weak-signal levels. It is part of the <u>WSJT-X</u> software suite. You can use WSJT-X to receive the LU1ZV beacon directly, or you can see reports from other stations online at <u>www.wsprnet.org</u>. ## **DOD COMEX 22-2**


US Army NETCOM will be utilizing 60 meters for amateur radio outreach from April 29 - May 7 as part of DOD COMEX 22-2. On May 3 at 0200Z (May 2 at 2100 Central), there will be a high-power broadcast about the information that will be requested during the exercise. US Army NETCOM will also announce times for amateur radio and AUXCOMM to net with DOD HF stations for the remainder of the week. Beginning on May 3 at noon local for each US time zone (East, Central, Mountain, Pacific), there will be a short net for amateur/AUXCOMM stations. In the evening, 2100 Central and noon local nets will conclude with the noon net on Saturday, May 7. NETCOM will be requesting support for collecting various types of information that may include road closure reports, METAR weather reports, and electrical power service availability. ## **UK Amateurs Exploring 40 MHz**

John Desmond, EI7GL, reports that Ofcom -- the communications regulator in the United Kingdom -- has granted temporary Innovation and Research licenses to several UK amateurs to transmit in the 40 MHz band.

On his blog, John stated that Roger Lapthorn, G3XBM, in the east of England will be operating beginning on April 2 with a license that is valid for 1 year. In a statement, Roger said, "After a very

long wait, Ofcom has approved my 8-meter permit. It permits me to use 40 to 42 MHz with digital modes (including CW) at 5 W ERP maximum. I expect to erect a wire dipole that will be directed towards



Europe. I expect to be mostly on FT8 around 40.676 MHz with a precise frequency done in liaison with others. My hope is all 8-meter FT8 stations can be monitored with one USB dial setting but spaced out. Five watts should certainly cover Europe when sporadic E is in play. I will try some local CW crossband QSOs but hope to be on FT8 24/7." [Thanks to Southgate ARC News] The ARRL Letter for April 1, 2022
